.Terms and Conditions for Yella Coming trans

### Definitions .1

- .a. "Yella Coming trans" refers to the courier service provided by Yella Coming trans
- b. "Customer" refers to the person or organization who engages Yella Coming Courier .Services to transport goods
- .c. "Goods" refers to any item or package that is transported by Yella Coming trans

### Bookings .2

- a. Bookings for Yella Coming trans must be made in advance and can be made via phone, .email or online
- b. All bookings must include accurate information about the goods being transported, .including the weight, dimensions, and destination
- c. Any additional services required, such as insurance or special handling, must be requested .at the time of booking
- d. Any cancellations made within 24 hours of collecting the goods will incur a cancellation .fees of 20% of the total booking cost

### Payment .3

# Liability .5
